

Rental agreement bicycles - Conditions

The tenant agrees to the following GENERAL TERMS AND CONDITIONS:

The renter declares to have received the bicycle (s) in good condition and to bring them back in the same good condition. In the event of damage or theft, of any size, or for any reason, the tenant undertakes to compensate for the damage or theft **incurred**. For this, the tenant will receive an invoice within 8 days after the determination of the damage suffered.

If the amount of the damage is greater than the deposit, the tenant must immediately settle this additional amount. This is noted on the rental contract. The lessee is obliged to immediately report any claim or accident to the renter, at the latest upon return of the bicycle(s).

The tenant ensures in advance (upon collection) the good condition of the rented bicycle that is legally in order. Any comments will be noted on the rental contract.

When picking up the bike(s) at the Burgschelde 36-38, 9700 Oudenaarde, a deposit of 300 euros per bike in cash will be charged. If this condition cannot be met, the agreement will lapse. When returning the rental bike(s) at the end of the agreed term, in good condition, the renter will immediately receive this deposit back.

The breakdown of inner and/or outer tires, as well as all other material damage to the bicycle is at the expense of the renter. Any extra service by l'Amusette will be charged at 60€/h.

The lessee is at all times responsible for the rented equipment, both in the event of accident, damage, violations and theft. In the event of damage to the rented bicycle or accessories, the renter must pay the repair to be carried out to the lessor upon return. Prices depend on the damage: parts are charged at retail prices - 15% + hourly wage.

In case of paint damage, 10% of the retail value of the bicycle will be charged (as a depreciation in case of sale afterwards). This regulation does not apply if the (paint) damage is in different places. In that case, a specification must be drawn up to determine the damage sum.

In the event of theft or loss of the rented bicycle or accessories, the tenant must immediately pay the lost good to the lessor.

The amount charged is the same as the value needed for replacement of the bike/part/accessory.

The lessor is not responsible for accidents caused by incorrect use and / or any defects in the bicycle (s).

The rent must be paid in advance and is considered acquired.

The hours per day are determined as follows: All day from 09:00 to 18:00. If a bicycle is not returned on time (before 6 pm) to the address of l'Amusette, an extra period will be added at the daily rate per day started.

LOSS OR THEFT OF THE BICYCLE(S)

The excess for the renter in the clause is **3,500 euros** per bike.

In case of loss or theft of the bicycle (s), the tenant must ALWAYS report to the local police station. The tenant must provide 1 copy of this declaration to the landlord.

The courts of the judicial district of Ghent have exclusive jurisdiction for any disputes. In the absence of timely payment, interest of 10% as well as compensation of 10% (with a minimum of 75 euros) are due by operation of law and without notice of default.

By booking the rented object, the tenant automatically agrees with the rental conditions.

CANCELLATION CONDITIONS

- In case of cancellation > 30 days in advance: cancellation fee 10% of the rental amount
- In case of cancellation 30-15 days in advance : 50% of the rental amount
- In case of cancellation < 15 days in advance : 100% of the rental amount
